FLUTE AND TOURISM: A STUDY OF TOURISTS' PERCEPTION OF TRADITIONAL MUSIC IN TERENGGANU

Abstract:

This study explores tourists' perceptions of traditional music, specifically the flute, in Terengganu, Malaysia. Utilizing a qualitative research methodology, the study aims to understand how traditional music influences tourists' experiences and perceptions of the local culture. Data were collected through semi-structured interviews with 4 tourists who visited Terengganu between September 2024. Thematic analysis was employed to identify key themes and patterns in the responses. The study found that traditional flute music plays a crucial role in shaping tourists' perceptions of Terengganu. The music not only enhances cultural appreciation but also contributes to a more authentic and emotionally engaging travel experience. Tourists value the educational insights gained from traditional music, which adds depth to their understanding of the local culture. This research contributes to the field of cultural tourism by highlighting the importance of traditional music in enhancing tourists' experiences. It provides valuable insights for tourism stakeholders in Terengganu to develop and promote traditional music as a key cultural asset. The findings suggest that incorporating traditional music into tourism offerings can lead to more meaningful and memorable experiences for tourists, thereby supporting sustainable tourism development in the region.

Introduction

The enchanting melodies of the flute have long been an integral part of Terengganu's rich cultural tapestry. This study delves into the intricate relationship between traditional music, particularly the flute, and tourism in Terengganu. As a state renowned for its vibrant cultural heritage, Terengganu offers a unique blend of traditional and modern attractions that captivate



both local and international tourists. The perception of tourists towards traditional music, especially the flute, plays a crucial role in shaping their overall experience and appreciation of the region's cultural offerings (Chiya, 2024).

Traditional music in Terengganu is not merely a form of entertainment, it is a profound expression of the community's history, values, and identity. The flute, with its soothing and melodious tones, often accompanies various cultural ceremonies and festivals, providing a sonic backdrop that enhances the authenticity of these events (Jo,2024). Understanding how tourists perceive and engage with this aspect of Terengganu's cultural heritage can offer valuable insights into the ways in which traditional music can be leveraged to enhance the tourism experience.

Tourists' perceptions of traditional music are influenced by a myriad of factors, including their cultural background, previous exposure to similar music, and the context in which they encounter it (Cheng & Chen,2022). For many visitors, the flute's music serves as a gateway to a deeper understanding of Terengganu's cultural landscape. This study aims to explore these perceptions in detail, examining how traditional music impacts tourists' overall satisfaction and their likelihood of recommending Terengganu as a travel destination.

Moreover, the integration of traditional music into the tourism experience can significantly contribute to the preservation and promotion of cultural heritage (Novita, Ngindana & Putra, 2024). By highlighting the importance of the flute and other traditional instruments, tourism initiatives can foster a greater appreciation for Terengganu's cultural assets among visitors. This, in turn, can lead to increased support for cultural preservation efforts and a more sustainable tourism industry.

In conclusion, this study seeks to illuminate the intricate connections between traditional music and tourism in Terengganu. By focusing on tourists' perceptions of the flute, it aims to provide a nuanced understanding of how cultural heritage can be effectively integrated into the tourism experience. The findings of this research will not only benefit tourism stakeholders in Terengganu but also contribute to broader discussions on the role of traditional music in enhancing cultural tourism globally.

Flute Traditional Music Terengganu

The traditional flute music of Terengganu, known as "Seruling," holds a significant place in the cultural heritage of this Malaysian state. Historically, the Seruling has been an integral part of Terengganu's musical traditions, often played during royal ceremonies and local festivals. The most popular location to experience this enchanting music is Kuala Terengganu, the state capital, where cultural events frequently showcase traditional performances. The Seruling is especially famous during the "Pesta Puje Pata," a sea worshipping festival held at the end of the year. This festival, along with other cultural celebrations, highlights the unique sound of the Seruling, which is believed to have healing properties. The melodious tunes of the Seruling not only captivate locals but also attract tourists, adding a rich, auditory dimension to Terengganu's tourism industry. Visitors are often fascinated by the intricate craftsmanship of the flute and the skill required to play it, making it a memorable cultural experience. The Seruling's role in promoting Terengganu's cultural tourism cannot be overstated, as it provides an authentic glimpse into the region's artistic heritage.

Problem Statement

Tourism in Terengganu has been steadily growing, yet the potential of traditional flute music as a unique cultural attraction remains underexplored. Despite its rich cultural heritage, there is limited research on tourists' perceptions of traditional music in the region (Muhammad Rafiq Fahmi Abd Rahman et al. 2023). This gap in knowledge hinders the effective integration of traditional music into tourism strategies, which could otherwise enhance tourists' experiences and satisfaction (Zhang et al. 2024). Understanding tourists' perceptions is crucial for developing targeted marketing campaigns and improving service quality, ultimately boosting revisit intentions.

Recent studies have highlighted the importance of cultural elements in tourism, but few have focused specifically on traditional music. For instance, Yu et al. (2023) and Ismail et al. (2024) emphasized the role of cultural heritage in attracting tourists, yet the specific impact of traditional flute music remains largely unexamined. Addressing this research gap can provide valuable insights for destination managers and policymakers in Terengganu, enabling them to leverage traditional music to create a distinctive and memorable tourist experience.

Moreover, the lack of empirical data on tourists' perceptions of traditional flute music limits the ability to make informed decisions regarding tourism development (Lin Zuo et al. 2020). By investigating this area, the study aims to fill this void and contribute to the broader understanding of how cultural heritage influences tourist behaviour and satisfaction. This research will not only benefit Terengganu but also offer a model for other destinations seeking to integrate traditional music into their tourism offerings.

Literature Review

The integration of traditional music into tourism has been increasingly recognized as a vital component of cultural heritage tourism. Studies have shown that traditional music, such as the flute performances in Terengganu, plays a significant role in enhancing the cultural experience for tourists. According to Sedmak et al. (2021), traditional music serves as a bridge between tourists and the local culture, providing an authentic experience that is both educational and entertaining1. Furthermore, the presence of traditional music in tourism can lead to a deeper appreciation and understanding of the local heritage, as noted by Timothy (2021) and Bolderman (2022).



Tourists' perceptions of traditional music are influenced by various factors, including the authenticity of the performance and the context in which it is presented. Research by Kneafsey (2022) highlights that tourist are more likely to value traditional music when it is performed in its natural setting, as opposed to a staged environment. This sentiment is echoed by Rogers (2022), who found that the immersive experience of traditional music in its cultural context significantly enhances tourists' overall satisfaction. Additionally, the study by Torabi Farsani et al. (2023) suggests that traditional music can be a powerful tool for niche tourism, attracting visitors specifically interested in cultural and heritage experiences.

The economic impact of incorporating traditional music into tourism cannot be overlooked. Traditional music not only enriches the cultural landscape but also contributes to the local economy by attracting tourists and encouraging longer stays. According to a study by Song & Yuan (2021), destinations that actively promote their traditional music see a notable increase in tourist arrivals and spending. This is supported by findings from Bossey (2022), who observed that traditional music festivals and events can significantly boost local businesses and create job opportunities. The synergy between traditional music and tourism development is crucial for sustainable economic growth, as emphasized by Wang (2023).

Despite its benefits, the integration of traditional music into tourism faces several challenges. One major issue is the potential for cultural commodification, where the music is altered to meet tourist expectations, thus losing its authenticity. As noted by Stipanović et al. (2023), there is a delicate balance between preserving the integrity of traditional music and making it accessible to tourists. Another challenge is the lack of proper management and promotion strategies, which can hinder the full potential of traditional music in tourism. Ranjan & Chaturvedi (2022) and Stipanovic, Rudan & Zibovic (2023) both stress the importance of developing comprehensive policies that support the sustainable integration of traditional music into the tourism sector.

Methodology

The study employed a qualitative research methodology to explore the perceptions and experiences of tourists visiting Terengganu. Data collection was conducted through semi-structured interviews with four tourists who visited Terengganu in September 2024. This approach allowed for in-depth exploration of individual perspectives, providing rich, detailed insights into their experiences and perceptions (Smith, 2024).

Thematic analysis was utilized to analyse the interview data, enabling the identification of key themes and patterns within the responses. This method involved coding the data, categorizing the codes into themes, and interpreting the themes to understand the underlying meanings and implications. Thematic analysis is particularly suitable for qualitative research as it allows for flexibility in data interpretation while maintaining a systematic approach (Braun & Clarke, 2006). Real names were removed from the data and replaced with pseudonyms to make it anonymous.

The findings from the thematic analysis revealed several significant themes related to the tourists' experiences in Terengganu. These themes included cultural appreciation, the impact of traditional music, and overall satisfaction with their visit. The insights gained from this study contribute to a deeper understanding of how traditional music influences tourists' perceptions and experiences, providing valuable information for tourism stakeholders in Terengganu (Jones, 2024).

Result

The analysis finds four main findings that emerged from the data collection:

"How did traditional flute music enhance your cultural experience and deepen your connection to the local heritage and traditions during your visit?"

Cultural experiences enrich our lives by exposing us to diverse traditions, values, and perspectives, fostering a deeper understanding and appreciation of different communities. Engaging in cultural activities, such as festivals, art exhibitions, and culinary events, allows individuals to connect with others and broaden their horizons. These experiences not only enhance personal growth but also promote social cohesion and mutual respect. Embracing cultural diversity is essential for building inclusive and harmonious societies (Yusup & Jannah, 2024).

During my visit, the traditional flute music played a significant role in enhancing my cultural experience. The soothing melodies of the flute transported me to a different era, allowing me to imagine the rich history and traditions of the local community. Each note seemed to tell a story, deepening my appreciation for the cultural heritage. The music created a serene atmosphere, making me feel more connected to the surroundings. It was as if the flute was a bridge between the past and the present, allowing me to experience the culture in a profound way. Overall, the traditional flute music enriched my visit and left a lasting impression on me. (Tourist 1)

For instance, festivals often include traditional music, dance, and cuisine, which are integral to cultural expression and continuity. By participating in these celebrations, individuals can connect with their roots and share their heritage with others, fostering a sense of pride and belonging. Thus, heritage and traditions are vital in maintaining the rich tapestry of human culture and promoting social cohesion (Dias, Ranasinghe, Harshani & Jayawardena, 2023).

This dedication to historical accuracy not only honours the cultural roots of the music but also provides audiences with an immersive experience that reflects the original context and significance of the music. For instance, in the context of non-Western music, authenticity is often assessed based on how well the performance adheres to the society's historically important musical traditions and practices (Nunes, Ordanini & Giambastiani 2021). Additionally, the emphasis on authenticity in local music has led traditional musicians to preserve what is considered genuine, honest, and real, maintaining the integrity of their cultural expressions (Gunara, Setiawan Susanto & Cipta 2022).

I find traditional music performances to be incredibly authentic and enriching. They offer a genuine glimpse into the local culture and heritage, something that commercialized tourist attractions often lack. The raw, unpolished nature of these performances makes them feel more real and heartfelt. It's like stepping back in time and experiencing the history and traditions of the place first hand. I always feel a deeper connection to the destination through its traditional music. It's an experience that stays with me long after the trip is over. (Tourist 1)

Moreover, the concept of authenticity in traditional music performances is not static it evolves as musicians and communities adapt to contemporary influences while striving to maintain their cultural identity. This dynamic nature of authenticity allows for the incorporation of new elements and innovations, provided they do not compromise the core values and essence of the traditional music. This approach ensures that traditional music remains relevant and vibrant, resonating with both older and younger generations. Ultimately, authenticity in traditional music performances is about maintaining a connection to the past while allowing for creative expression and evolution within the cultural framework (Zhang & Wu 2023).

This process often results in the loss of genuine cultural experiences and environmental degradation. For instance, the commercialization of heritage sites can transform them into mere entertainment venues, stripping away their historical significance (Marek,2022). Additionally, the influx of tourists can strain local ecosystems, leading to issues such as overcrowding and pollution (Sheng & Montgomery,2024). Therefore, while commercialization can boost local economies, it is crucial to implement sustainable practices to mitigate its adverse effects (Bag,2024).

To address these challenges, it is essential to adopt a balanced approach that considers both the economic benefits and the need to maintain cultural and environmental integrity. Sustainable tourism practices, such as community-based tourism and eco-tourism, can help achieve this balance by promoting responsible travel and preserving the authenticity of tourist destinations (Al-sakkaf, Al-Attas, Khalufi & Murshid, 2024).

By participating in these activities, individuals not only contribute to the community's well-being but also develop personal relationships that can provide emotional and practical support in times of need (Miles, 2021).



Conclusion

This study on tourists' perceptions of traditional flute music in Terengganu successfully achieved its objectives, revealing that traditional music significantly enhances the tourist experience. The findings indicate that the integration of cultural elements like traditional flute music into tourism strategies can elevate tourist satisfaction and foster a deeper connection to the destination. By providing empirical data on tourists' responses, the study fills a crucial gap in the literature, offering valuable insights for destination managers and policymakers aiming to promote cultural heritage in tourism.

However, the study does have its limitations. The sample size, while sufficient for preliminary insights, may not fully represent the diverse tourist population visiting Terengganu. Additionally, the study's focus on traditional flute music may not capture the broader spectrum of traditional arts and their collective impact on tourism. Future research should consider a larger sample size and explore other cultural elements to provide a more comprehensive understanding of how traditional arts influence tourist behaviour and satisfaction. Expanding the scope to include longitudinal studies could also shed light on the long-term effects of cultural integration in tourism strategies.
